4. I have observed that the road has been open to the public for all to use, to come and go as they pleased, since at least as early as the late 1950s and continuing through 1976 to the late 2006. 5. Throughout the time period from the late 1950s to 2006, I have used the road myself for wood gathering, hunting, pine nuts gathering, sight seeing and travel in and through the area.


