2. I have traveled and am familiar with a road in Beaver County known as Indian Creek Powerline Road. I am also familiar with the land the road traverses. When I first used and observed the road in 1941, it followed the same route as in 2006 when I last observed it. Attached is a Beaver County map showing Indian Creek Powerline Road. To the best of my knowledge and based upon my use of and familiarity with this road and the land it traverses, the location and route of the road are correctly illustrated on the attached map.

3. I am informed that the County also identifies this road according to the road number listed above.

4. I have observed that the road has been open to the public for all to use, to come and go as they pleased, since at least as early as 1941 and continuing through 1976 to 2006. Throughout this time period I have observed travel on the road by means of ATVs, pickup trucks, jeeps and cars. Throughout the time period from 1941 to 2006 the road was used daily.

5. Throughout the time period from 1941 to 2006, I have used the road myself for hunting, farming and livestock operations.

6. Throughout the time period described in the previous paragraph, I have observed

other vehicles from the general public using the road at various times for the uses described in the previous paragraph, plus residential access.






BEAVER COUNTY "B" ROADS




