1. I am an adult competent to testify about the matters set forth below based upon my personal knowledge. I currently reside in Beaver, Beaver County, Utah. I have lived in Beaver County most of my life.

2. I have traveled and am familiar with a road in Beaver County known as Bald Ridges Road. I am also familiar with the land the road traverses. When I first used and observed the road in 1947, it followed the same route as in 2006 when I last observed it. Attached is a Beaver County map showing Bald Ridges Road. To the best of my knowledge and based upon my use of and familiarity with this road and the land it traverses, the location and route of the road are correctly illustrated on the attached map.

3. I am informed that the County also identifies this road according to the road number listed above.

4. I have observed that the road has been open to the public for all to use, to come and go as they pleased, since at least as early as 1947 and continuing through 1976 to the present. Throughout this time period I have observed travel on the road by means of pickup trucks and cars. Throughout the time period from 1947 to 1976 the road was used daily and is presently used weekly.

5. Throughout the time period from 1947 to 1980, I have used the road myself for livestock operations.

6. Throughout the time period described in the previous paragraph, I have observed other vehicles from the general public using the road at various times for the uses described in the previous paragraph plus hunting, wood gathering, recreation and travel in and through the area.





BEAVER COUNTY "B" ROADS




8. Prior to 1976, I observed the graded surface of the road. In the past 20 years, I have also participated in the maintenance of this road.



MAP VIEW AREA


