TO ALL WHOM THESE PRESENTS SHALL COME, Greeting:

Know ye, This is an Acknowledgment and Notice of Acknowledgment made under Utah Code § 72-5-309 through 310 inclusive that the grant of the United States of America of “the right of way for the construction of highways over public lands, not reserved for public uses” under United States Revised Statutes 2477 (43 U.S.C. § 932 (repealed October 21, 1976, with proviso recognizing the validity of rights-of-way already established)) was accepted for and on behalf of the State of Utah and its political subdivision Sevier County as it pertains to the highway located in Sevier County known as 1017d, 1017da_Lost Creek to Re; County Road Number: 6043; State Geographic Information Database (SGID) Road Identification Number: RD210018. Total road length is 4.53 miles more or less.


The reasons for this acknowledgment are as follows (indicated by an “X” in one or more blocks and any supplemental comment):







Beginning at a point on the road centerline located at 38 degrees 48 minutes 33.74 seconds North Latitude and -111 degrees 50 minutes 49.61 seconds West Longitude, which can be converted to mapping accuracy State Plane Utah Central Zone NAD 83 feet coordinates of X = 1,541,494.5 feet and Y = 6,735,254.5 feet based on the US Survey Foot conversion.

Ending at a point on the road centerline located at 38 degrees 52 minutes 02.92 seconds North Latitude and -111 degrees 52 minutes 04.47 seconds West Longitude, which can be converted to mapping accuracy State Plane Utah Central Zone NAD 83 feet coordinates of X = 1,535,656.3 feet and Y = 6,756,442.1 feet based on the US Survey Foot conversion.
