Pursuant to 43 C.F.R. §4.411, the State of Utah hereby provides notice that appeals the Decision Record for the Bureau of Land Management’s (BLM) Labyrinth Rims/Gemini Bridges Travel Management Plan, dated September 28, 2023 (DOI-BLM-UT-Y010-2020-0097-EA), issued by Nicollee Gaddis-Wyatt, BLM Canyon Country District Manager. Appellant the State of Utah is adversely affected by the BLM’s Decision Record and has the right to appeal pursuant to

43 C.F.R. §4.410(a).

This notice of Appeal is timely filed within 30 days after the BLM issued its Decision Record, pursuant to 43 C.F.R. §4.411(a)(2)(i).
